Sustaining fishing stocks.

In an effort to maintain our sport we have agreed to implement annual voluntary measures such as barbless hooks, a shortened Fowey season and higher catch/release rates for both sea trout and salmon.

We need evidence to show how these measures are working for the membership. Please email comments to the Club Secretary at

sec@ldac.org.uk or write to him at Lower Hollycombe, Drift Lane, Twowatersfoot, PL14 6HH so that we can gather information to inform the FRA's next meeting about the impact of voluntary measures with the EA in early 2019.

For now we will start the 2019 season with the measures introduced in 2018 still in force.

- ***Barbless hooks only before June 16th for all fishing methods on all rivers.***
- ***Barbless hooks to be used for all bait fishing at all times on all rivers.***
- ***Closure of Fowey season on 30th November 2019***
- ***First salmon caught on each river to be released***
- ***Maximum of one salmon retained per season per river***
- ***Maximum of 2 sea trout taken per day***
- ***Maximum 10 sea trout taken per season (cumulative; all rivers)***
- ***Release all sea trout over 55cm and under 35cm***

You will all no doubt be aware that 2019 will see the introduction of new EA measures to help secure salmon stocks across the country. Our southwest rivers are no exception and we can expect to see permanent restrictions on hook size and number/type of hook, and strict catch/release targets for salmon. These may complement or supersede our voluntary measures. We will no doubt be hearing about this from the EA in due course, especially those of us that have taken the opportunity to consult with the EA directly.

We will advise members of any changes on the Club website - but it is anglers' responsibility to be aware of and abide by all EA and Club rules.

Chairman's update

Unfortunately the 2018 season has been one of the most difficult years that I can remember with river levels in general having been extremely low throughout most of the year.

This has meant that catching fish has been difficult to say the least, and almost impossible for many who were unable to take advantage of the rare occasions when rain did fall.

It would be helpful if I could report that the Restormel Fish Counter had shown good numbers of fish running despite water levels; but sadly we were informed late in the season by the EA that the sensors on the central channel have been defective for the best part of the season - hence there is no reliable data. From visual reports sea trout numbers on all rivers were below average; this appears to reflect a similar picture nationally.

On the brighter side the start of the season on the Fowey did produce some early Spring salmon and amongst them a good fish of 16lb. Summer grilse did continue to sneak through on the low water and a few were caught aided by the Colliford release water which gave good flow to the section of river below the St Neot confluence. However very few anglers made an effort to fish due to low river levels and the extremely hot weather. November finally brought heavy rain and with it much improved river levels. Several salmon were caught although they were certainly not easy to find.

On the Lynher we had reports of Summer grilse making their way through the river in the low water but again they were difficult to catch with very few anglers making the effort. Towards the end of the summer good numbers of salmon were seen in many of the holding pools on the lower and middle stretches of the river and some members who fished after the short spells of rainfall were rewarded with a fish or two.

It is certainly not all doom and gloom; remember that last year the 2017 season saw over 1,000 salmon/large fish and some 8,000 sea trout/small fish recorded over the Restormel Fish Counter on the Fowey and the salmon rod catch on the Lynher one of the best in recent years (see Secretary's report herein for further details).

Electo-fishing carried out by West Country Rivers Trust on the Fowey catchment were very encouraging with 20 out of the 30 sites surveyed showed trout numbers with a classification of "A" or "B". Salmon juvenile numbers in the main stem of the river between Ashford Bridge and Respryn Bridge were also the highest recorded during the past six years.

Despite the worryingly low number of sea trout running the river this year there were still shoals of fish observed holding up in the pools at Trago Mills and on a recent visit to the Draynes Spawning Sanctuary I witnessed excellent numbers of good-sized sea trout digging redds throughout the valley. I am hopeful that we will not get the big winter spates that we have seen in recent years and spawning conditions will remain favourable through year-end.

On my inspection I noted many of the spawning areas in the Draynes Sanctuary have deteriorated over the last year or two, partly due to the lack of volunteer work parties but also as a result of the hot dry summer which produced ideal conditions for an increase in the growth of *Hemlock Water Dropwort*. Also many sites on the main river where salmon have traditionally spawned are now compacted and could do with some *TLC*. The few of us that have been responsible for these operations in the past are getting older and feeling the strain so we will need more members to step forward and take ownership of this important work.

This year we introduced additional restrictions that were agreed with the FRA and the EA on both fishing methods and catch limits. These were deemed necessary in order to protect the existing stocks of fish in our rivers. Unfortunately the poor conditions that prevailed during the season will probably not give us a true picture of how they are impacting on our fishing.

The Committee however remains convinced that we need to work closely with the EA in order to remain in charge of our own affairs/regulations and avoid mandatory Bye Laws.

As you are aware we still await any decisions following the National Consultation on The Management of Salmon Fisheries but in the meantime the FRA will meet again with the EA in January or February of 2019 to review the voluntary measures and we would ask our members to bear with us and support the club during these difficult times as we try to balance the need for conservation whilst also protecting the interest of our members.

As you know, earlier in the year I sent out a communication to all members asking for your support in a bid to purchase additional fishing rights on the River Fowey at Newbridge. I would like to sincerely thank all those of you who responded in such a generous way.

We had hoped to have positive news for you in this newsletter. Regrettably, despite our offer being accepted and the sale progressing through to solicitors the vendors withdrew the stretch from sale in late November. We cannot therefore proceed with the purchase.

As always there remains much to do on our fishing beats to clear trees and debris and improve habitat for juvenile fish. Much of this work will be carried out during our "Bank Clearance" days and a timetable of dates is printed in this newsletter so please come along and help out.

Finally I would again like to thank our Secretary Paul Jordan for all his hard work in putting this newsletter together and all the members of the Committee for their continued hard work and support and finally

one which will hopefully bring better fishing conditions.

I look forward to seeing many of you at the AGM when we can keep you up to date in more detail.

Obituary: Dr Mick Smith

Just before the end of the 2018 season the Club was saddened to hear of the passing of Dr Mick Smith, from Draynes, Liskeard. As many will know, Mick was a long serving member of the LDAC Committee and a great supporter of the Draynes sanctuary project.

Please do pause to reflect on Mick's passing and his long and faithful service to our Club.

Secretary's report

As another year comes to an end it is time to reflect on what has kept us occupied in the last season.

The Committee met six times during the year. Overall attendance by Committee members at the meetings was 85%.

Fishing aside it was a year that saw the start of major changes to how and when we fish our waters.

- LDAC pre-empted the possibility of any EA bye-laws and a further decline of Fowey fish stocks by agreeing voluntary measures with the EA to protect the river. This has paid dividends with a net limitation order of zero being agreed with the EA on the Fowey for 2019 and beyond - and we should see a positive result for our efforts. We must also thank the FRA for their support and help in achieving this very positive outcome.
- The new LDAC rules came in at the same time as we were witnessing first hand the impact the emergency EA Camel bye-law was having on the fishing clubs that rely on that water for their membership.
- We are also aware of the impending National Salmon Fisheries Plan, which will impact not just where and when we fish, but how we fish as well. This plan is likely to be enacted by the EA before the start of the 2019 season.

It has therefore been a very difficult time for the Committee as they struggle to find the right balance between maintaining important relationships and protecting fish stocks, whilst also providing our members with some of the best fishing available in the southwest.

All of this whilst organising and supporting work parties, balancing the books and looking for and securing opportunities to help build a solid future for the Club.

We maintain over 21 miles of fishing, across diverse river systems, all at a very competitive price. This year we also tried to secure the purchase of a significant new stretch of the Fowey, above Newbridge. With the purchase all agreed and funds in place we were very disappointed when we heard that the Vendors were withdrawing from the sale at the last minute.

We continue to rely heavily on the goodwill of our riparian owners for continuing to lease other quality water to us – and it is good to report that relationships with these key stakeholders remain positive.

We have also worked to ensure access/ownership was maintained over our short stretch of the Lynher at and above Turnpike Cottage (New Bridge, Lynher). The Club has invested both time and money in fencing off and creating access points for you to use.

The Committee were pleased to see a marked improvement in rod catch numbers for the 2017 season and I am particularly gratified to be able to say that once again all members exceeded our catch/release targets.

- 2017 Lynher and Fowey catch/release figures for salmon were 95% and 91% respectively
- 2017 sea trout catch/release rates were good on both the Lynher (85%) and the Fowey (79%).
- The 2017 season saw a significant increase in the total of rod-caught salmon *year-on-year*, rising from 59 (in 2016) to 134 in 2017, increasing by 227%. Sea trout numbers

also rose, from 202 (in 2016) to 325 in 2017, an increase of 161% *year-on-year*.

- On a river-by-river basis the Fowey fared better than the Lynher with a higher number of rod-caught salmon (94 in 2017 *versus* 32 in 2016, up 294%) with that river also producing 201 sea trout, *versus* 126 in 2016, up 160%.
- The Lynher also saw an increase in salmon numbers *year-on-year*, from 26 (in 2016), to 40 in 2017, a rise of 54%; 2016 sea trout numbers also rose, from 39 (in 2016), to 86 in 2017, up 221%.
- The Inny produced no reported sea trout in 2017, one less than in 2016, perhaps because of low fishing efforts. Remember the Inny is open for grayling fishing even when our other rivers are closed.
- 18 sea trout were reported from the Seaton (up from 14 in 2016), an increase of 29%.
- 20 sea trout were reported from the West Looe, (up 58% from 13 in 2016) with a catch/release rate of 80%.

Regrettably working party turnout was well down in 2018, no doubt due in part to falling interest as new rules and restrictions came into force.

Members must come forward and support the work-parties before the new season starts in 2019, to report any areas that they consider require attention and then to support our requests for additional work during the season. The pre-season dates/locations are listed in this newsletter.

We understand that additional work is often warranted or needed later in the season – but with total reliance on the same few dedicated volunteers to do all the work it is just not possible for the Club to address all 21 miles of riverbank - without starting to resort to outside contractors. This is not viable if Club ticket costs are to be kept as low as practical.

We would once again urge members to carry out their own (sensitive and sensible) clearance of undergrowth across and along footpaths as they pass through whilst fishing during the season.

If you can help make sure we have your up-to-date contact details so we can contact you directly.

Your Committee members attended Fowey River Association (FRA), Lynher River Association (LRA), Tamar and Tributaries Fisheries Association (TTFA) and Camel Fisheries Association (CFA) meetings and AGM's to ensure the Club interests are fully represented. Information from these is shared via the Club newsletters/website where appropriate.

News, new initiatives and general information

EA Emergency Bye Law on Camel extended into 2019.

The EA attempted to reach a voluntary agreement with the angling interests on the Camel in order to lift the emergency bye-law that was due to expire on 30th October 2018.

Regrettably the parties were unable to reach any form of agreement on voluntary measures and so the EA has extended the emergency bye-law for a further 6 months – ***until end March 2019.*** It is likely that the River Camel will then be under the control of the new national measures that the EA is implementing across England and Wales to preserve salmon stocks.

The extended bye-law requires all anglers to comply with

- 100% catch/release. All salmon caught by rod and line to be returned with minimum delay, whether alive or dead
- The use of worms for salmon fishing is prohibited
- Spinners, plugs and other artificial lures to be fitted with single barbless hooks only
- Hooks used with artificial fly to have maximum gape of 8mm
- Prawn or shrimp may be fished in conjunction with a barbless hook with maximum gape of 8mm
- 2019 season (for salmon, sea trout and brown trout) starts 1st May 2019
- Above measures in force until 30th March 2019 unless revoked or changed by the EA.

Conservation & Hatchery News:

1. Fowey Hatchery: 2018 Report

What a year - rain, snow, sun and more sun.

Anglers don't need reminding that these conditions are not great for migratory fish angling - but spare a thought for the Hatchery too.

Just behind the Hatchery are over 28 billion litres of water - it's always wet, even before the terrific rain we saw in January and February - then the big freeze of March where even getting to the Hatchery was tough. Finally it got really hot. These little fish are resilient indeed!

Nevertheless Colliford Salmon Hatchery continues to meet or exceed all the performance targets set by the regulatory bodies that police our programme each year. A lot of effort goes into recording in great detail all the water and air conditions and the oxygen levels - we try to spot any problems that may be building and make adjustments to the environment.

LDAC anglers came out in support to help collect brood-stock and several anglers phoned to have a fish collected during autumn 2017. We stripped a really nice set of eggs and hatched them in a very clever new system that controls water temperature.

This is done by means of ventilating the building, chilling the water or raising the dissolved oxygen levels. We also administer some prophylactic treatments to keep the fish in good health in their closed environment.

We stocked our 2017/2018 fish out in the St Neot river in September of 2018 (40,000) and then cleaned-down ready to start the 2018-19 programme.

LDAC members continued to be the backbone of the brood-stock collection programme for winter of 2018 and we are on target to produce 40,000 fish for stocking again next year, lacking just a couple of cock fish at the time of publication.

All these things take time and money - and so it is very important to recognise the contributors and the workforce. While the Management role is a part-time, paid position there is also a large amount of volunteer effort that goes into staffing, brood-stock collecting, annual leave cover, stripping fish, treatments and stocking out. There is also a contract to manage and the hardest job of all – paying for it all.

We couldn't do this without the continued support of South West Water and the Fowey Rivers Association - and of course the Clubs, Associations and Riparian owners, not least Liskeard & District Angling Club.

2. Lynher Hatchery: 2018 Report

The last 12 months has proved to be the most successful one for the hatchery since it was established more than 10 years ago.

Later brood-stock collection, colder water pre-Christmas 2017, the introduction of a new egg tray system and water-cooling equipment all contributed to the success.

Initially some 65,000 eggs were stripped, and their development was slowed with the water-cooling system only having to be used periodically since ambient water temperatures were low.

After hatching commenced successful trials were made with the planting out of advanced eggs into several side streams, followed by swim-up fry introductions to several feeder streams and the main river. Some 32,000 fry were introduced this way.

The remaining fry were reared on and stocked later in the summer, bringing the total stocked to an impressive 56,500; an egg/stocked fry percentage of 87%.

Our previous best year saw a total of 42,000 fry stocked, so the increase this year was extremely encouraging.

Brood-stock collection for this year has already commenced largely due to the efforts of Graham Hake. To date the fish taken are predominantly grilse, with larger fish being scarce, and this may limit the number of eggs we eventually obtain. We remain grateful to those riparian owners who allow us access for out-of-season collection.

All this success was achieved at a cost of approximately £3,000 - equating to just over 5p per fry stocked.

We remain grateful to our main donors the LDAC and Woodcocks Syndicate, plus other individual contributors, on whom we are totally reliant to continue operating the hatchery.

Once again we must acknowledge the help of Nick Lintott who provides the hatchery site, and is Graham's main helper, together with John Body, Jon Hake, Vic Lamb, Colin Lewis and Tom Macpherson, all of whom contributed to the success. Also we must acknowledge the support and sharing of information/ideas with the SWW/FRA Fowey hatchery at Colliford Reservoir.

Without the unpaid support of our volunteers the financial viability of the hatchery would cease, and a huge thank you goes to all concerned.
