# 6. Work Party changes

We continue to encourage all members to keep bankside pathways clear as they fish through our various beats by careful clearing and removal of obstacles such as fallen branches. If any areas need additional resources details can be emailed to the secretary@ldac.org.uk. These will then be reviewed and dealt with by ad hoc work parties that are organised for such areas. It is expected that by giving the membership ownership of identifying problem areas more useful accessibility will be created.

In this regard it was reported that significant log-jams had developed below Golitha Falls, blocking migration pathways. They have now been removed utilising financial support from the FRA (www.riverfowey.org). This organisation has put in place a rolling 5-year programme with WRT to ensure access to the Draynes Sanctuary area is maintained. Utilising this programme WRT carried out the necessary work for LDAC and the migration pathway is fully open.

## 7. Chairman's Report

As another season draws to a close we can reflect on a season with decent water levels throughout the summer months.

Normally this would mean that members could catch a few sea trout and the odd salmon or grilse; but unfortunately the lack of sea trout in our rivers is becoming increasingly concerning.

Indeed in the past members caught more sea trout that salmon but recently it appears to be reversing trend.

There is widespread concern across the country about this decline in sea trout numbers but no one has the answers yet. Perhaps some effective at-sea protection from commercial fishing boats would help?

The Committee has been very active this year removing fallen trees and keeping paths clear. In this regard I was pleased to meet a member who complimented me on our housekeeping, stating how pleased he was to be in a Club that looked after the riverside so well.

As you will see from the Hatchery reports later in this newsletter there continue to be excellent releases of juvenile fish into both the Fowey and Lynher, which can only be good for the future of both rivers.

I hope our members were able to enjoy the better water conditions this year, and in this regard I share the best fishing advice I ever received

"....if you go often you will have more blank days but you will have more good days too....and you certainly won't catch anything sitting at home."

Finally I would like to thank all the Committee members who at very short notice turned out to fell 54 ash trees in Lewarne Woods, in dark wet and windy conditions during the last A38 night closure. A job well done!

Merry Xmas and a Happy New Year to all our members and I look forward to seeing you all at the AGM in February.

# 8. Secretary's report

# 8.1 Abstraction on the Fowey

Despite the implementation of the SWW drought permits in winter 2022/spring 2023 the wet weather and efforts of SWW to identify and capture incremental supplies of water during 1Q 2023 meant that Colliford Reservoir was back up to acceptable levels during this summer. As a result no additional abstraction was necessary in the autumn of this year and the immediate threat of more drought permits has gone away.

However SWW advised that they would be looking to replace their current abstraction licence on the Fowey with a new one that would have increased their annual take of river water by 25%; this would clearly result in magnifying the already significant threats to migrating salmonids that the current abstraction levels create.

As part of the Fowey Fisheries Resource Group (FFRG) the Secretary requested EA data and EIR data from SWW pertaining to flows, abstraction and river levels.

Utilising this and after a few online research sessions it transpires that whilst the current (abstraction) licence allows for onset of abstraction when a volume of 1.207cumecs is maintained flowing over Restormel Weir into the estuary.

EA published research suggests that this should be set much higher, at 1.9 cumecs. Indeed through the Secretary's this is now formally recorded by the EA/FFRG.

Armed with this information SWW were then advised that any new abstraction licence which sought to increase annual abstraction volumes would be met with a legal challenge (utilising Fish Legal). The focus of the challenge would have been around lifting the abstraction threshold flow to the (now proven) 1.9 cumecs level before any increase in abstraction could occur

With the threat of being challenged SWW have retracted their application for a new licence and whilst we have no recourse to challenge the existing licence there is now no longer the threat of losing another 25% of the Fowey flow to SWW.

## 8.2 2022 Catch Return Report

The season saw an increase in the total of rod-caught salmon *year-on-year*, rising from 88 in 2021 to 98 in 2022 (a rise of 11%). However, sea trout catches dropped catastrophically again this year, falling from an already record low of just 102 to a worrying number of 64, (a further drop of 37%). This is again the lowest recorded number of sea trout caught on LDAC waters since catch returns began to be recorded in 1994 and is illustrating a

disturbingly steep decline in sea trout numbers in our rivers.

On a *river-by-river* basis the Fowey fared better than the Lynher with overall number of rod-caught salmon (69 *versus* the 58 taken in 2021, up 19%); the River Fowey however only producing 57 sea trout in 2022, compared to the previous historic low of 76 in 2021, down another 25%. Catch and release figures show 100% for salmon and 95% for sea trout on the River Fowey.

The Lynher saw salmon numbers maintained at 28 *year-on-year*. Sea trout numbers again fell, from a previous historic low of 17 (in 2021), to a disturbing number of just 6 fish in 2022, a further drop of 65%. Catch and release figures show 100% for salmon and 83% for sea trout.

Minor rivers saw even fewer fish; 1 salmon off the Camel, 1 sea trout off the Inny and nil returns for both the Seaton and West Looe. Both the Inny and Camel reported 100% catch/release.

Whilst it is too early to speculate on how the 2023 season has been, anecdotal evidence seems to reflect a fair run of salmon occurred early on but there has been another marked absence of sea trout in both the Fowey and Lynher. Numbers seem to be significantly lower than our worst year on record, and that, of course, was just last year.

# 9. Treasurer's Report

2023 has once again been a very challenging year for the Club financially.

Our income is solely reliant on membership numbers and we have seen these once again drop to a new historically low of just 88 adult members.

Anticipating the future, and seeing a consistently *low* membership number for several years we once again need to raise income levels to allow the Club to break even in 2023.

# For 2023 the Committee has therefore increased all subscription categories by £5.00.

Adult subscriptions will therefore rise to £115.00 pa and Disabled subscriptions will rise to £100.00 pa.

Some other rates will see a bigger increase.

Renewal subscriptions must be received by the 1st of April 2024 to ensure we have sufficient cash-flow to operate the Club effectively. Failure to do so will mean that late returning members will again be liable for paying the full (re) joining fee, now set at £25.00.

Subscriptions can be paid by cheque (payable to LDAC) or, if you prefer, by BACS (bank details below) – but those members renewing by BACS *must* also still notify the Treasurer by post, and provide a SAE with their mandatory catch returns to enable their season ticket to be sent out for 2024.

Beware: No ticket means No fishing!

# 10. Conservation & Hatchery News

# **Fowey Hatchery (Colliford)**

At the time of writing (late November) we have perfect water conditions on the riverbank and in the hatchery. The reservoir has recovered from the drought and the air and water temperature have plummeted in the cold autumn weather. This has brought our brood-stock fish on really well and yesterday we stripped 4 fish, in November, the earliest we have stripped fish since moving to Colliford in 2016.

We produced a really strong stocking of parr in the and stocked them without summer out anv drama. Brood-stock collecting for this year's program has been very weather dependent and we have been battling the leaves for what seems like the whole of October and November. LDAC provide the backbone of the brood-stock fish and anglers – and special mention must go to Jason Drew who has been in daily contact to know what fish we have and what fish we need, catching nearly half our allocation of brood-stock fish singlehandedly. In truth he did need help to net a particularly large salmon in a big river and was ably assisted by Jon Hake. I am sure that fish will put in an appearance in the Trophy awards at next year's AGM.

Finally I would sign-off by reporting on the number of finclipped fish that have been caught in the last few years – and again urge all LDAC anglers to report them using the form - <a href="https://form.jotform.com/222064387756362">https://form.jotform.com/222064387756362</a> The EA will monitor the performance of the Hatchery based on these fish reports – and we have had a growing number each year since the form launched in 2020. Many thanks again to everyone involved.

# **Lynher Hatchery**

The 2022/23 cycle proved to be another good year for the hatchery with nearly 45,000 fertilized eggs obtained.

Egg losses were minimal, resulting in just under 42,000 fry being stocked to the river, of which 60% were Autumn stocked reared on fry. The ratio of eggs stripped to fry stocked was 94% - a very impressive result thanks to the hard work of our volunteers. Cost per fry stocked was 5 pence.

The start of the new 2023/24 cycle has not been without problems, the river running high for much of the time since the season close. Thanks to the efforts of our brood-stock collectors we have at the time of writing (end November) our quota of hen fish, mainly MSW ones.

However cock fish are proving hard to find. Unless we find more we will be faced with returning un-stripped hens back to the river, which will limit our egg numbers.

We continue to remain grateful to our unpaid volunteers and donors, including LDAC, without whom we could not function.
